All pre-audits, audits, and post-audits will be completed before the end of the contract term. 3D PREA Auditing and Consulting LLC will work with staff and inmates at each of the selected facilities to complete the objectives of the certified PREA audit. 3D Auditing and Consulting will work within the audit standards to complete interviews, surveys, and other research to summarize each facility's progress toward becoming fully compliant with PREA. 3D PREA Auditing and Consulting LLC will report findings of the audit to the Department as well as any recommendations on resolving any areas of non-compliance and will present any and all findings to the department in writing. 3D PREA Auditing and Consulting LLC understands that all audit activities completed or performed will be partially grant-funded and follow all standards of the certified PREA audit as well as the State of Missouri Department of Corrections rules and administrative directives.

During the post audit phase, the auditor will review collected information and documentation, determine the level of compliance with each standard, and provide each facility with an auditor report. If corrective action plan is necessary the auditor will present those findings to the facility, and those facilities will take action ensure to compliance with PREA standards. Once the corrective action is completed, the auditor will prepare the final report.

Time needed to conduct a PREA audit will range from one to five working days depending on the facility size, agency readiness, and record keeping. While at the facility 3D PREA Auditing and Consulting LLC will tour the physical plant; interviewing staff, contractors, and volunteers; interviewing inmates/detainees/residents; and reviewing facility records. The facilities will be required to post a notice of the audit in each housing unit of the facility to be audited. This notice should be in place six weeks prior to the audit, and must include an address at which the auditor can receive confidential correspondence prior to the onsite audit activities and through the issuance of the final report. If 3D PREA Auditing and Consulting LLC determines that the facility "Does not meet Guidelines of the PREA standard" with respect to any standard provision, 3D PREA Auditing and Consulting LLC will develop a corrective action plan jointly with the agency. 3D PREA Auditing and Consulting will verify that the implementation of corrective action plan is completed within 180 days, and issue a final determination, and complete a report to the department that includes the findings of the certified auditor and any recommendations for bringing the audited facility into compliance. 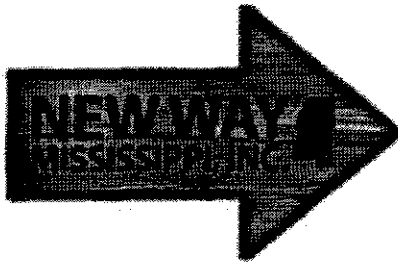

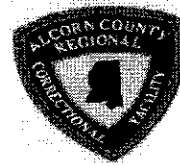

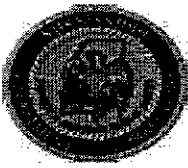
