Services will be provided at the agency and from partners in the local recover oriented systems of care and MRP team through active collaboration and re-entry coordination. The program offers a combination of counseling and wraparound services. This grant will fulfill gaps in services, supplement needed services for offenders eligible for Access To Recovery program, and provide services for successful re-entry to offenders not eligible for ATR.
